Warranty LooseLay Luxury Vinyl Plank

Lifetime Residential and 15-Year Commercial Limited Warranty

Twelve Oaks takes every effort to stringently control quality production of all of our LooseLay Vinyl floors. All of our luxury vinyl floors are Floor Score certified.

Twelve Oaks extends a Lifetime Residential and 15-Year Commercial Limited Warranty, from the date of purchase, to the original purchaser of who resides in the area where Twelve Oaks LooseLay vinyl floor was originally installed. Light commercial limited warranty is only applicable to LooseLay vinyl floors that are installed directly over subfloors that are in pristine conditions. This warranty is NOT transferrable. Proof of purchase and a copy of the original invoices are required to claim the warranty. Any Twelve Oaks material purchase through unauthorized dealer/sources will be excluded all warranty.

Twelve Oaks' warranties are for replacement or refund of the material only, and do not cover mouldings, accessories and the labor cost such as but not limited to installation, removal of the defect materials, and moving of the furniture or other fixtures.

STRUCTURAL INTEGRITY WARRANTY

Twelve Oaks warrants all luxury vinyl floors, in their manufactured condition, to be free from material and workmanship defects. This includes milling, assembly, and dimension. Twelve Oaks LooseLay vinyl floors will be highly moisture-resistant, and will not delaminate, loose the original pattern and color, show excess fading and wear, when installed and maintained according to installation instruction.

Should there be any doubts concerning the quality of Twelve Oaks product, the purchaser must call the local authorized dealer before installation. If defect was only notifiable once the planks have been installed, stop the installation and contact local authorized dealer immediately. Purchaser is given 30 days after discovering the defect and within the period of this limited warranty to make a claim. The surface wear and defect must be readily visible and covers an area greater than one (1) square inch of the floor surface. If Twelve Oaks honors a claim under this limited residential/commercial warranty, replacement of defective board will be free of charge. In the case that the product becomes discontinued, Twelve Oaks will replace a board of equal value, quality, and similar design (whenever possible), free of charge. All replacements are prorated based on the time of purchase.

Twelve Oaks reserves a period of 10 business days, upon receipt of a claim, to inspect the product/jobsite. During this

period, any attempt to repair, replace, or refinish will void this warranty.

WARRANTY EXCLUSIONS

Twelve oaks will NOT accept any claim due to noncompliance with Twelve Oaks' written policies and installation instruction, shipping damages, the use of improper adhesives, inadequate sub-flooring or improper sub-floor preparation, improper maintenance and care, neglect, misuse or abuse, and/or the lack of proper humidity/temperate control.

The following list of incidences will NOT be covered under warranty:

- Luxury vinyl floor is exposed to heavy commercial traffic, and/or heavy commercial maintenance schedules
- Variation of color, texture or pattern, and gradual change of color from exposure to sunlight or artificial light over time
- Excessive surface wear as a result of improper care and cleaning (i.e. cuts, dents, scratches, use of unapproved cleaner)
- Damage caused by flood, erosion, insects, burns, fire, pets, Act of God, and any other accidents
- Modification, alteration, repair, or other services by nonauthorized floor covering dealer
- Problems associated with improper installation, uneven or unleveled subfloor, non-compliant subfloor conditions, and/or improper care or maintenance.
- Improper use to tools and adhesives during installation

IMPORTANT

Twelve Oaks require that the relative humidity level where floor is installed be consistently kept between **30% and 55%**, and room temperature at **65-85°F (18-29 °C)**. These environmental conditions are specified as pre-installation requirements and must be maintained for the life of the floor thereafter.

Installation over radiant heating system required to be full spread glued down to the subfloor. Please refer to our Installation Instructions for more detail. Twelve Oaks' Warranty will be voided if an improper installation over radiant heat system is demonstrated.
